We support 6 lacrosse teams at schools in underserved communities of south Dallas, TX. The teams play lacrosse against mainly middle to upper middle class teams. We run lacrosse clinics in south Dallas. We run summer camps, partnering with another organization. We sent over 30 kids to two out of state lacrosse camps. In all we reach approximately 400 at risk youth yearly. Our program has grown every year for the five years we have been doing it. We also provide after school study hall for our players. They are at supervised study hall from the time school lets out until lacrosse practice starts. As part of our program we provide healthy food and good eating habit instruction to our population. With the exception of a paid contract executive director we do all this with volunteers from the lacrosse community. We believe we have had a significant impact on our youth and on the lacrosse community as a whole. Providing a quality program for underserved kids enriches their lives and the lives of the volunteers who serve them.
